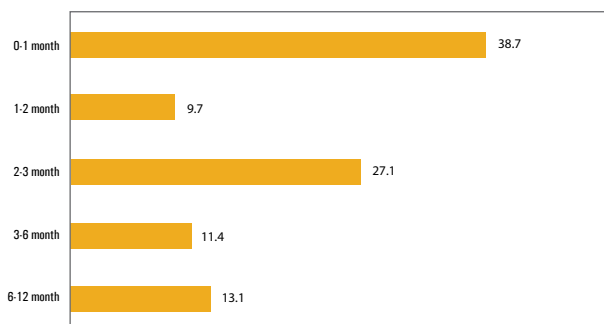

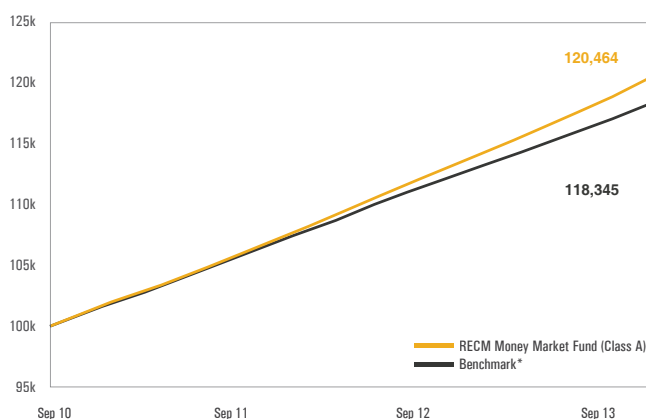

### INVESTMENT COMMENT

The RECM Money Market Fund generated an income yield of 6% against the SteFI-call benchmark yield of 5.1% in February 2014. Portfolio duration amounted to 80 days and was unchanged from January 2014. January headline CPI came in at 5.8% from 5.4% in December 2013 and was above the market consensus of 5.7%. The increase was mainly attributable to the 39 cents per litre increase in the petrol price combined with higher food price inflation. GDP growth registered 3.8% for the fourth quarter 2013. The money market yield curve steepened off the back of the higher CPI print with persistent Rand weakness further contributing to market expectation of additional rate hikes this year. The fund maintains a 55% weighting towards floating rate instruments with the primary banks and remains competitively positioned in the event of a rising interest rate cycle.
