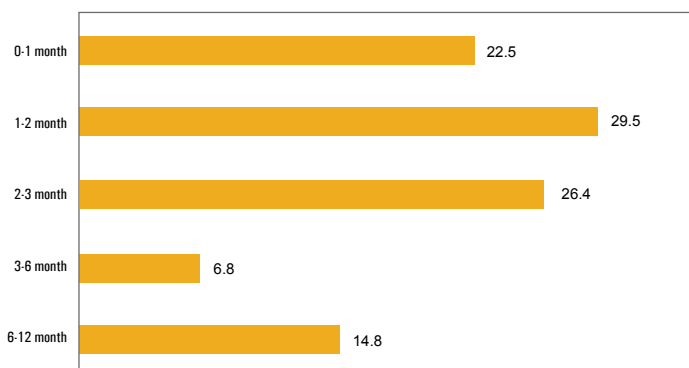

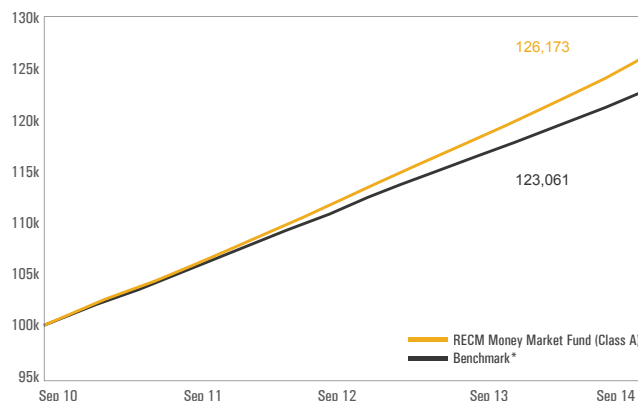

INVESTMENT COMMENT

The RECM Money Market Fund is positioned to deliver an effective yield of 6.6% over the next 12 months. For the month of November the fund returned 0.53% versus the STeFI Call Rate return of 0.41%. Fund duration increased from 79.3 to 86.5 days. We have maintained duration within the 60-90 day range to take advantage of the yields on longer dated instruments. Domestic headline inflation remained constant at 5.9% in October, whilst producer level inflation decreased to 6.7% from 6.9%. The main drivers were lower food and fuel costs. The SARB kept the repo rate unchanged at 5.75% following the MPC meeting, highlighting a lower inflation trajectory and weak economic fundamentals. The view remains that there will be a normalisation of interest rates over time. The timing, however, will be dependent on domestic growth fundamentals, inflation expectations and the rate at which the US hikes interest rates. We continue to positively position the portfolio competitively with an approximate weighting of 50% between fixed and floating instruments. Currently we have no exposure to corporate instruments but we continue to look in both primary and secondary markets for attractive value.
